Renewal Bonus Guidelines

Renewal bonus does not apply in the following states: CT, IL, MS, NV, WA

Payment details:

- Bonus payment will be paid out in May 2026 to your agency. Your agency is solely responsible for paying any bonus amount to you.
- One-time payment (Not Per member Per Month (PMPM)).
- The above table outlines the number of renewed members enrolled and the amount per member that you will earn. Please note that enrollments from FL, ID, KY, NM, TX, OH, SC, and UT cannot be combined with CA enrollments. California enrollments will be calculated separately.
- Bonus amounts must be earned by each broker individually. Enrollments by a broker will not be added to enrollments by a different broker for purposes of meeting the # of overall renewed members.
- Bonus will be calculated based on book of business (BOB) through 3/31/26 (i.e enrolled for 90 days)

Program terms and conditions:

- Renewing membership only.
- Members must effectuate on 1/1/26.
- These payments apply to renewal business in CA, FL, ID, KY, NM, TX, OH, SC, UT only.
- California renewals cannot be combined with FL, ID, KY, NM, TX, OH, SC, UT renewals.
- These payments do not apply to CT, IL, MS, NV, WA
- Members must remain enrolled with Molina Marketplace for three months.
- Members with data discrepancies in the 834 report will not be included in the bonus calculation.
